Section 12. Sub-sections 4, 5 & 6

Pursuant to sub-section 5, the Commissioner of Valuation has determined that the increase in the Valuation of premises indicated by the letter "A" in the Buildings Column of the Valuation Lists was made on an application for the revision of such Valuation by reason of the erection, enlargement, or improvement of a building to which the Section applies.

Where an increase to which this Section applies is made in the Valuation of any tenement to a portion of which a separate Valuation is now assigned, the proportion of the Valuation attributable to each portion of the tenement before the increase as determined by the Commissioner of Valuation in accordance with the provisions of Sub-section 6, is shewn in black ink, and the Revised Valuations are shewn in coloured ink. Such cases are indicated by the letter "B" prefixed in the Buildings Column of the Valuation List.
